Revista Ciencias Biomédicas receives original scientific articles on diverse topics in medical and health sciences: Basic Medicine, Clinical Medicine, Health Sciences, Biotechnology in Health and Other Medical Sciences.

Those interested in publishing in **Revista Ciencias Biomédicas** must comply with its editorial standards; articles proposed for publication will be subject to a double-blind review by recognized international peers in the area of evaluation.

We receive works written in Spanish or English, in the following categories:

- Letters to the editor
- Original scientific and technological research articles
- Review articles
- Reflection articles
- Case reports
- Management guides and protocols
- Imaging practice exercises
- Non-research reflection paper
- Bibliographic reviews

Format of articles

All articles must be presented in **electronic Word format (*.doc, *.docx), in size 12 letter, Times New Roman font, double space, and must be structured in the format of each type of article.** It is recommended to name drugs in their generic name; avoid the use of abbreviations, if necessary they should be defined in their first use in the text; international or multilingual symbols and abbreviations are allowed.

Submissions to **Revista Ciencias Biomédicas** must contain the following:

Autorization of article publication

Declaration of originality, ethics and good practices of publications

Title page: article title in Spanish and English, authors, affiliation, ORCID number of each author (if any), corresponding author, conflicts of interest and funding.

Abstract: in English: introduction, objective, methods, results and conclusions, (up to 250 words) and **Keywords.**

Resumen in Spanish: introducción, objetivo, métodos, resultados and conclusiones (up to 250 words) and **Palabras clave.**

Article text, each type of article must include the following:

Original scientific and technological research article: introduction, methods, results, discussion, references, tables, figures. It is recommended that the article have a maximum of 3000 words, we will evaluate the relevance of those that exceed this number.

Review article: introduction, methods, results and discussion, conclusion, references, tables, figures. It is recommended that the article have a maximum of 3000 words, we will evaluate the relevance of those that exceed this number.

Case report: introduction, case report, discussion, references, tables, figures. It is recommended that the article have a maximum of 2000 words, we will evaluate the relevance of those that exceed this number.

Exercise of imaging practice: medical history, diagnostic images, questions, comments, references

Reflection articles, letters to the editor, management guides and protocols, reflection papers not derived from research and bibliographic reviews: free format, references, tables, figures.

Acknowledgements (optional)

Contributions of the authors: Describe the participation of each author, using the following criteria: study conception and design, collection analysis and interpretation of data, writing of the draft of the article, critical review and approval of the final version,

responsible for the veracity and integrity of the article.

References: Revista Ciencias Biomédicas requires references in all original articles. References should follow the Vancouver format. Before submitting your article, please check the writing format.

This format requires consecutive citations with numbers in the text, describing at the end the list of references with their respective number assigned in the text. The citation format in the text is in parentheses. Example: "(1, 3, 4-6)".

Tables: the tables and charts will be called Tables, must be included in the text of the article, and must be listed consecutively (1, 2, 3, 4, 5, 6, etc.). Also, keep in mind the following sequence for table footnotes: ¹, ², ³, ⁴, ⁵, ⁶, etc.

Figures: The figures, drawings, photographs and illustrations shall be called Figures, shall be included in the text of the article and shall be listed consecutively: 1, 2, 3, 4, 5, 6. Images, photographs, microphotographs, laboratory test results, etc., must be also sent as annexes in image file (.PNG, .GIF, .JPG or .TIF.), with resolution between 300 and 600 dpi.

If non-original material, taken from books, journals, virtual media, etc., is included, credit must be given to the source and express authorization for its use and reproduction must be attached. It should be borne in mind that many published images and freely accessible via the INTERNET have copyrighted rights.
